If the response to all the questions is 'no' then the giving of an application for building control approval with full plans is appropriate for the proposed work. Where the response is 'yes' for row 1, an application should be made to the Building Safety Regulator. Where the response is 'yes' to any other row, an application for building control approval with full plans is not necessary for the work. For work in relation to row 3, please contact the local authority team for your area.

Building Regulation Application for Building Control Approval with Full Plans - Notes and Checklist

Plans are only full plans if they consist o

- a description of the proposed building renovation or replacement of a therr element, change to the building's en status or material change of use
- the plans, particulars and statement required by paragraphs (1), (1A) and **Regulation 13**
- where paragraph H4 of Schedule 1 imposes a requirement, particulars a precautions to be taken in building o drain, sewer or disposal main to con the requirements of that paragraph
- any other plans which are necessary show that the work would comply w Regulations.

The local authority must notify the appli of the outcome of the application within weeks beginning with the date the appli is received by the local authority, or with longer period as at any time the authorit the applicant agree in writing. If you wis extend the period of time that the local of has to notify of the outcome of the appl you can include this request with the ap for building control approval with full pla the local authority to consider.

Applicants should be aware that the Loc Authority will as required consult with sto bodies and pass on those details that yo submit on your application form for the purposes of granting the Building Regula application. Without this data collection could not process the application. Appli details are only passed on to the necessor statutory consultees.
